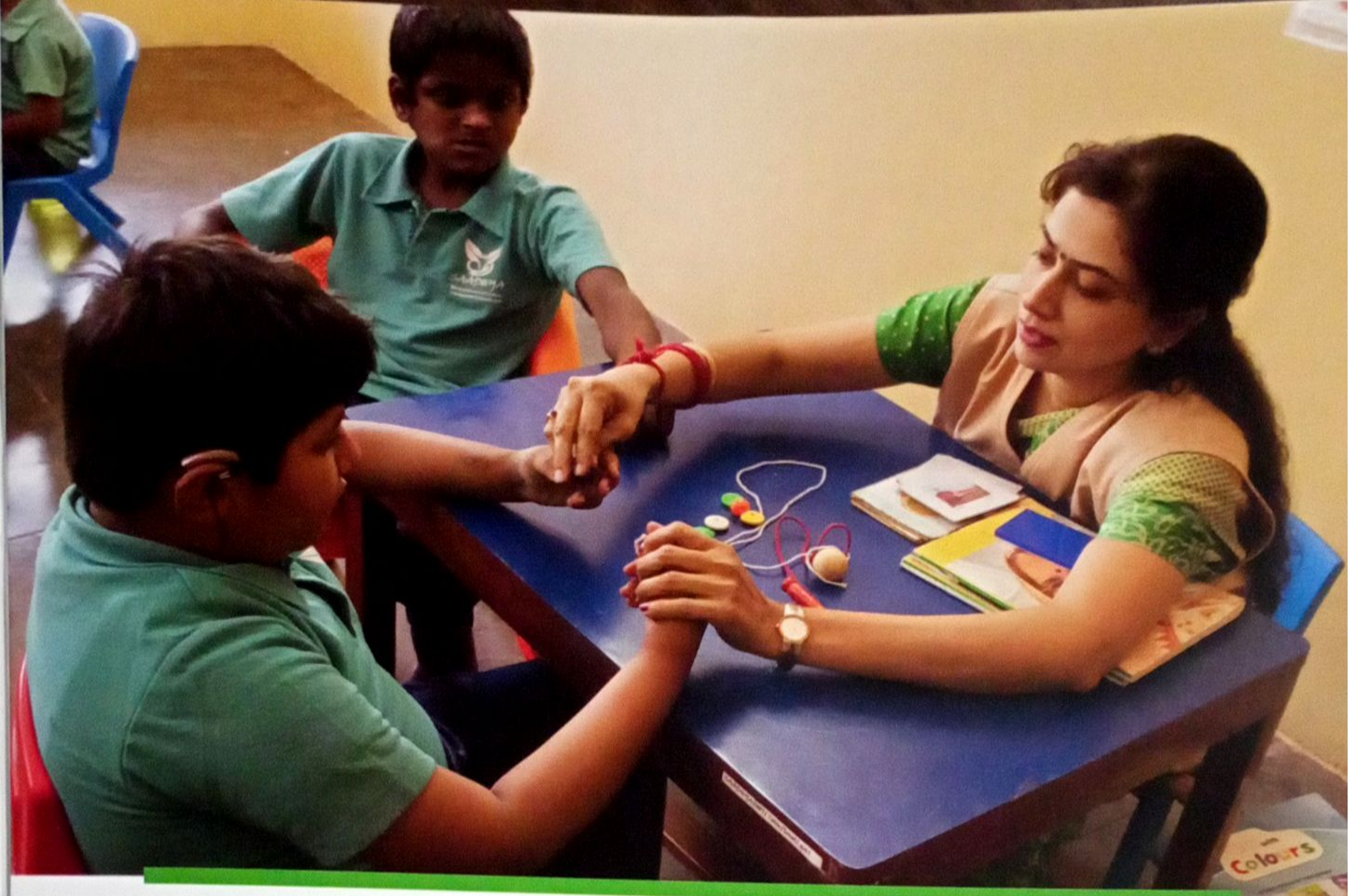

## ABOUT US

Our initiative began with establishing special schools in Hassan and Hosapete (Karnataka). These schools are recognized by Department of Empowerment of Differently Abled & Senior Citizen, Government of Karnataka and aspire to provide the highest quality of special education and vocational training to the Children & Adults with Intellectual Disability.

Barrier free inclusive society for Specially Abled.

## OUR MISSION

Driven by a passionate & self-motivated team, we aim to improve the social status of 2000 mentally challenged persons by 2030. With our innovative programs in special education, therapies, art & culture, sports, and vocational training, we facilitate inclusion & mainstream employment.

### **Saadhya Residential School & Vocational Training center for Specially abled at Hassan**

The school caters to the special needs of the children with intellectual Disability. Our team members and staff are trained in special education and vocational trainings. The school is having disabled-friendly infrastructure. We are not only focusing on special education, rather we also train children for Special Olympics, impart vocational training etc. The ultimate objective is to see every child in Saadhya become self-dependent in life skills.

### **Saadhya Residential School & Vocational Training center for Specially Abled at Hosapete**

This school caters to the special needs of the students with intellectual Disability, Autism and Multiple Disability. We have specialized professionals in Special Education, Autism, Physiotherapy, Speech Therapy, Yoga, Sports, Arts & Culture. Our students have been regularly participating in Special Olympics games. We wish to see these children become self-dependent and acquire life skills that will help them.

#### **Early Intervention:**

As part of our integrated approach, we identify children with intellectual disabilities at their homes through our early intervention initiative. This is designed as School readiness programme. The interventions are partly delivered at our residential school as well at the home of the child, so we can work closely with the parents.

#### **Training for Special Olympics:**

Special Olympics is a sport activity conducted by us to encourage and nurture the abilities of children with intellectual disabilities. We identify the abilities in the children, their understanding levels, capability to compete as well as self-management skills. Regular training is provided through specialized coaches in powerlifting, athletics, roller skating, cycling, floor hockey, floor ball, badminton, table tennis, judo, football, volleyball, cricket, bocce, and basketball. These children participate at district, state, and national levels. We have taken 15 children to National championships and 3 children have represented India at special Olympics, World games. **We have won 9 medals for our country so far.**

#### **Livelihood through Creative art and skill building:**

Our organization is focused on providing mainstream employment opportunities, and vocational training to children with disabilities. As a part of Go Green Initiative, we train students above the age 18 to make paper envelopes, bags. Additionally, we also train them to make candles and diya lamps, rakhis, and friendship bands during the festive seasons. Art pieces such as pen stand, garland, paper basket is also taught. These are distributed to local stores and their sale has created income source for our trainees with intellectual disabilities

We firmly believe that everybody can contribute to the society's needs and this initiative is a step towards including them in the society. One of the many ways that we try to do that is to engage them in activities that would pique their interest and improve their ability to do things on their own.

As a part of Go Green Initiative, we train students above the age of 18 to make paper envelopes. Since paper is a biodegradable source and a very good substitute than using plastics, we encourage in making our environment plastic free. We also ensure that these envelopes are sold in the market and each and every student gets the credit and remuneration for the works they have done.



### Special Olympics:

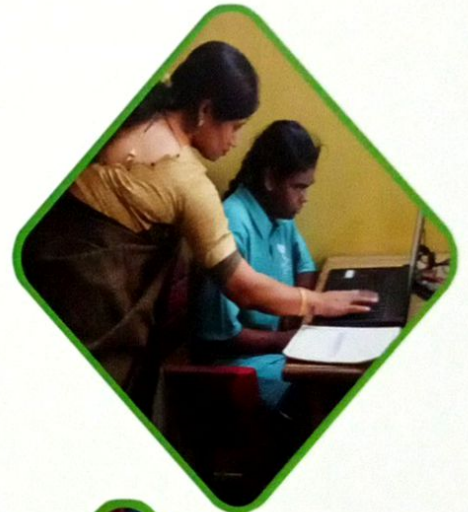
Special Olympics is a sport activity conducted by us to encourage and nurture the abilities of children with intellectual disabilities. Regular training is provided through specialized coaches in power-lifting, athletics, roller skating, cycling, floor hockey, floor ball, badminton, table tennis, judo, football, volleyball, cricket, bocce, and basketball.

Due to the outbreak of Corona Virus, we couldn't implement this activity on a large level, yet some of our students participated in this, they are:


